## ENTERTAINMENT AGREEMENT

IT IS MUTUALLY AGREED BY SGP AND THE CLIENT THAT:

1. The Client retains and employs SGP to provide Disc Jockey Entertainment for the event described below.

*SGP and the Client will arrive at the Total Price and Balance Due at a later date.*

*Both parties agree that this total will be based upon the above pricing structure.*

6. **Overtime:** In the event that Client would like SGP to play past the agreed Stop Time, service will be provided at the rate of \$20 per half-hour until 1:00 a.m. and \$30 per half-hour after 1:00 a.m.
7. **Deposit:** A non-refundable Reservation Fee is required to secure SGP for the event date(s). This amount shall be **subtracted from the total price** of the event (as shown above).
8. Client shall pay the **BALANCE DUE** in full plus any additional overtime charges by the end of the event. Payment can be made by cash, check or money order made out to **Chris Gangstad**.

9. If Client cancels this contract **LESS than 30 days prior** to the scheduled event, Client shall be liable for 50% of the total agreed price of the event (less any deposit made). If Client cancels this contract **MORE than 30 days prior** to date of scheduled event, Client will forfeit deposit amount, but not be liable for the balance. Postponements will only be permitted if postponement date is available. Original deposit will be applied to future event only if a new date is given within four months of original date.
10. Client must provide: A minimum area of 4' x 12' for DJ booth set up (plus room for speakers) within 25' of a reliable electrical outlet (2 separate circuits are desirable), and adjacent to the dance floor. If event is outdoors, please make sure there is adequate covering from outdoor elements **or** enough help on hand to help get equipment under cover quickly in case of adverse weather. SGP must have uninhibited access to the Event location at least 90 minutes prior to start time for the purposes of set up.
11. The conditions or guests at the Event shall not inhibit the performance, nor cause injury or threaten the safety of the Disc Jockey or any Property of SGP. Any loss or damage to property of SGP by Event guests or conditions is the responsibility of the Client. If the DJ determines that unsafe working conditions exist SGP reserves the right to cease performance immediately.
12. SGP will not be held liable for any damage or harm, to property or persons at the Event unless such is caused by gross or wanton negligence on the part of the DJ.
13. In the unlikely event that SGP is unable to perform at the Event due to illness or "Act of God" and suitable replacement is not found, SGP will refund any deposits or payments made by Client. If time is lost due to SGP, Client will have the option of extending the services for the amount of time lost at no cost. Otherwise SGP will refund the portion of the total amount prorated to correspond to time lost. This is the extent of SGP's liability and no other damages may be sought against SGP.
14. If weather conditions or "Act of God" cause the event to be canceled or postponed, Client must contact SGP at 402-268-4051 or 402-366-3762 (cell phone) no later than **four** hours prior to scheduled start time. If SGP arrives at event location but has not been notified as stated, Client will be liable for 50% of contracted price (less any deposit). If weather conditions prevent the DJ's safe travel home, please help arrange lodging for DJ.
15. If the Event concludes in less than the contracted number of hours, Client shall be liable for the agreed total price.
16. If for ANY reason, the Client fails to pay the BALANCE DUE by the end of the Event and satisfactory arrangements are not made a late payment fee of \$20 may be imposed by SGP. A \$20 fee will be imposed on any returned checks.

I will review all information and contact you if anything needs to be clarified. If everything is OK then I will sign it and return a copy to you. If this Entertainment Agreement and deposit are not received by the above date, I cannot guarantee your reservation and in the case that this date is secured by another party, this contract is considered void and any deposit payment will be returned.**
